Terms and Conditions

Please read carefully before you order Success Enforcer.

- **Payments:** that all these benefits are contingent on your subscriptions being kept up to date
 - The Monthly subscription will continue into year 2 and subsequent years unless you cancel your subscription.
- **Cancellation:** Success Enforcer is an annual subscription paid for in installments or up-front in advanced. The cost is £65 per month (£780 per year), or £699 for up-front payment which entitles you to 13 months on full membership instead of 12 (£81 value), plus a £1,101 up-front payment discount. So total benefit for paying upfront is: £1,182. The Basic Membership is currently discounted from £150 per month (£1800 per year).
 - If you wish to cancel you must put it in writing, and your following year of membership will be cancelled. We provide a lot of support and time into the Success Enforcer service, and it is for this reason that we CANNOT offer a monthly membership with immediate cancellation.
 - If you wish to cancel, you have 7 days to do so after your first payment is processed, if you do not cancel, you will have agreed by default to the 12 month term (which will be 12 payments not including your free month).
 - Your payments will occur every 30 days. If your account or card details change you MUST inform us immediately, as missed payments will incur a charge of £10 per decline.
- **Refunds Policy:** Any payments you have made are non-refundable (even if you didn't 'use' the service), and you agree not to seek a charge-back on fees paid. Any missed payments will result in a £10 fee.
- **VAT :** Currently VAT is not charged on the Success Enforcer service, however, should this policy change we may need to adjust the cost of your membership mid-cycle. If we do this, you will be informed in writing.

We will also offer you another product at a minimum of double to value of the VAT increase to ensure you are not too inconvenienced. VAT on the monthly package would total: £76.38 per month instead of £65.
